Following the Information Session, we will be administering the (TEAS) Technologies Institute Test of Essential Academic Skills test which is a requirement for admission.

LISTED BELOW ARE NECESSARY DETAILS CONCERNING THE SESSION:

- **Basic computer knowledge and a working email address are REQUIRED to take the test**
- High School seniors are encouraged to bring a parent during the session
- Please make arrangements for childcare – No children are allowed during the session
- The presentation will last approximately one hour, followed by the TEAS test which is 3-4 hours long
- A personal email address will also be required in order to register at the testing website
- Please bring photo identification
- A calculator and scratch paper will be provided
- Students are encouraged to study. You may purchase a TEAS study manual or take the practice test by going to www.atitesting.com. (*Please Note: We do not offer the study manual at MTC*)
- You must return the attached form including a \$30 *non-refundable* reservation fee in exact amount to reserve your spot.
- *Re-testing* dates will be available in the spring if needed. Another \$30 fee will be required ahead of time.

Qualified applicants will be considered for admission by a committee of qualified MTC staff members and nursing instructors. Applicants will only be considered if all criteria have been met. Applicants are encouraged to attend an Information Session/ TEAS test session as soon as possible to obtain details. Space in the program is limited, so applying early is recommended.
